old book No:3 pag 60 and the second to the first the second second the second s Know all men by these presents that I Jonas Wood Senior of Huntington upon Long Island in New York Shire have and do by these presents do Sell Alienate assigne and Make over from me my heirs Executors administrators and assigns for a Considerable Sum in hand paid all my right title and Interest in an allotment by Denomination of a Two Hundred pound Lott formerly in the Tenure or Occupation of George Sutton Since alienated from him the Said Sutton unto Mr. James Miels of Virginia and Since attached and prosecuted in Law by me Jonas Wood aforesaid and given to me by the Court of Sessions in the East Riding finding my prosecution to be Just and Legall I Say all my Right title and Interest in and to the premises I have Sold and made over unto Joseph Bayly of Huntington upon Long Island In York Shire aforesaid his heirs Executors administrators and assigns forever To Have hold occupy and Injoy without any fraud Trouble or Molestation of any person or persons whatsoever firmly by these presents or as fully as may be made by any deed or Conveyance Whatsoever with all Lands priviledges Accomodations profits and Revenues thereto

Belonging or ariseing therefrom as also all houseing out housing orchards Barnes Gardens pastures meadows and priviledges I the aforesaid Jonas Wood do by these presents Sell alienate and Estrange from me my heirs Executors administrators and Assigns all my Right title and Interest unto the aforesaid Joseph Bayly his heirs Executors administrators and assigns TO HAVE AND TO HOLD forever and I do by these presents Ingauge myself my heirs Executors Administrators and assigns to Save harmless and Indemnified the Said Bayly his heirs and assigns from any person or persons Whatsoever Who Shall or may Lay any Claim or Title to the aforesaid Lott or any part or parcell thereof to the Indemnifying the Said Bayly or his Successors in his or Either of their Quiet possession as Witness my hand this Sixteen day of July in the Twentieth year of the Reign of Charles the Second King of England Scotland france and Ireland Et Cetra and In the year of our Lord one Thousand Six hundred Sixty and Eight According to the Computation of the Church of England
